## ORDINANCE NO. 2196

AN ORDINANCE LEVYING THE TAXES TO BE ASSESSED AND COLLECTED IN THE CITY OF YOAKUM, IN DEWITT AND LAVACA COUNTIES, TEXAS FOR THE YEAR 2022, FOR USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF YOAKUM, TEXAS FOR THE 2022-2023 FISCAL YEAR; APPORTIONING EACH LEVY FOR SPECIFIC PURPOSES; AND, PROVIDING WHEN TAXES SHALL BECOME DUE AND WHEN SAME SHALL BECOME DELINQUENT IF NOT PAID

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF YOAKUM, TEXAS:

SECTION 1 There is hereby levied for the year 2022 A.D. and shall be assessed against all property subject to taxation to the City of Yoakum, DeWitt and Lavaca Counties, Texas and not exempt by law from taxation and shall be collected in the manner provided by law and the Ordinances of the City of Yoakum, Texas, the sum of \$0.12023 on each One Hundred Dollars (\$100.00) valuation of such taxable property. Said tax levied for the purposes herein set out and is apportioned in the following manner, to-wit:

\$ 0.12023	TOTAL TAX RATE
\$ <u>0.04741</u>	for the payment of principal and interest on debt of this City
\$ <u>0.07282</u>	for the purpose of maintenance and operation

## THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE

THE TAX RATE WILL EFFECTIVELY BE DECREASED BY 3.6% AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$0.00.

<u>SECTION 2</u> Taxes shall be due and payable upon receipt of statement and become delinquent on February 1, 2023, all in accordance with the provisions of Section 31.02 of the Property Tax Code of the State of Texas.

<u>SECTION</u> 3 If any section or part of this ordinance be held unconstitutional or invalid, the remainder of this ordinance shall remain in force and effect.
