This project provided for approximately 2,452 linear feet of 12" waterline and all necessary appurtenances for the City of Yoakum. A final public hearing to review and comment on the program performance including the actual use of funds will be held at 6:00 p.m. June 14, 2022 at the Yoakum City Hall 808 Hwy 77A South, Yoakum, Texas. All citizens and interested groups are invited to attend and comment on this matter.
